3.2 REVISED LENGTH OF CONTRACT

DELETE:

This contract will run for one (1) year with options to renew the contract for three (3) additional one (1) year terms.

ADD:

This contract will run for two (2) years with an option to renew the contract for one (1) additional two (2) year term.

III. REVISED TERM

DELETE:

This Agreement shall commence on August 20, 2010 and shall expire on August 19, 2011 ("Term").

ADD:

This Agreement shall commence on August 20, 2010 and shall expire on August 19, 2012 ("Term").

III. REVISED OPTION TO RENEW

DELETE:

The Authority shall have options to renew this Agreement for three (3) additional one (1) year renewal terms. Prior to the expiration of the Term or any renewal term, the Authority may elect to extend this Agreement, in whole or in part, for an additional period of one year.

ADD:

The Authority shall have an option to renew this Agreement for one (1) additional two (2) year renewal term. Prior to the expiration of the original Term, the Authority may elect to extend this Agreement, in whole or in part, for an additional period of two (2) years.
